Ms. Zweig's community service as a lawyer is wide-ranging. In the Southern District Court of Indiana she has been appointed to several Magistrate Judge Application Review Committees as well as serving on Magistrate Judge reappointment committees. She has been an appointee of the Indiana Supreme Court to its Disciplinary Commission for a tenure of ten years and during that time served as its Chair, Vice-Chair, Secretary and Treasurer. She later fulfilled an appointment by the Court to the Indiana Pro Bono Commission.

She is a past Chair and a charter member of the Indianapolis Inns of Court, and Past President of the Board of Directors of the Indiana University McKinney School of Law Alumni Association. She has also served on the Board of Directors of the Legal Services Organization of Indiana and is an active member of the Defense Trial Counsel of Indiana and the Medical Device and Products Committee of the Defense Research Institute.

Ms. Zweig has served on the Board of Directors of the Indianapolis Bar Association and has co-chaired the Bar Association's Professionalism Committee. She is a *Distinguished Fellow* of the Indianapolis Bar Foundation, a *Fellow* of the Aspen Institute Justice & Society Seminar, and served as a panelist for the Oxford University Centre for Socio-Legal Studies' Social Justice and Economics. She has been recognized on the Indianapolis Business Journal's Who's Who in Law list and as a Super Lawyer® every year since its inception.

A mayoral appointee to the Board of Directors and Executive Board of the Greater Indianapolis Progress Committee, Sally was also honored to serve as Co-Chair of the Race Relations Leadership Network for a number of years.

In the broader community her service on various Boards of Directors has included: The Art Center of Indianapolis, At-Your-

School Services, the Advisory Board of the Spirit and Place Festival, and the Festival Music Society.

Prior to becoming a lawyer, Ms. Zweig was one of the founders of Indiana's first Guardian *Ad Litem*/Court Appointed Special Advocate (CASA) project that laid the groundwork for providing independent representation and services statewide to children in the juvenile court system due to abuse and neglect. That program has expanded state-wide and has served thousands of children adjudicated "in need of services" with a network of hundreds of dedicated and well-trained volunteers comprised of both lawyers and inspired lay people.
